#### **INVITATION TO BID**

The Calhoun County Commission (sometimes herein referred to as "County") will receive competitive sealed bids until Tuesday, September 10, 2024, at 2:00 p.m., Central Time, for the purchase of new HVAC, PTAC and/or Heat Pumps, (sometimes herein collectively known as "New Units") to be used on county buildings at different locations. It is the intent of the County to purchase these units on as "as needed" basis and does not guarantee a minimum or maximum number of units that will ultimately be purchased under the terms of this bid. Please note that these bids WILL NOT be opened during a commission meeting; however, they are still opened publicly and each vendor is encouraged to attend the bid opening.

Be it known that if the units as specified in this invitation are identified as "Carrier", "Fujitsu", "Lennox", etc. brand, they are shown for illustration purposes only. Any brand of comparable size and quality will be given complete and unqualified consideration in the award process. Exceptions to the bid must be included in bidder's bid.

Specifications for the new units are on the attached Bid Sheets.

The bidder shall furnish a draft copy of the warranty information with his/her/its bid. Each selected bidder shall submit to the County upon delivery of the new units a warranty certificate. Bidder may submit additional warranty options as an exception to the bid. Exceptions to the bid must be included in bidder's bid.

Sealed bids with the words "HVAC/PTAC/HEAT PUMP UNITS" on the outside of the envelope or package containing the bid must be submitted to the Calhoun County Commission, 1702 Noble Street, Suite 103, Anniston, Alabama 36201, no later than Tuesday, September 10, 2024, at 2:00 p.m. Bids sent by facsimile transmission, email, telegraph, or telephone will not be accepted. Bids will be opened on Tuesday, September 10, 2024, at 2:00 p.m. Central Time, in the Calhoun County Commission Meeting Room, 1702 Noble Street, Suite 103, Anniston, Alabama 36201.

Notwithstanding anything else herein provided, the Calhoun County Commission reserves the right to reject any and all bids, to waive any formality in bids, and to accept in whole or in part, a bid, solely at its discretion, if in Calhoun County Commission's judgement, the best interests of Calhoun County and the Calhoun County Commission will thereby be protected and/or served. The Calhoun County Commission also reserves the right, to the fullest extent allowed by applicable laws and regulations, to negotiate with the lowest, responsive, responsible bidder selected.

County does not guarantee that County will buy one of the "new units" or any specified number of the "new units", and County reserves the right to not order any of the "new units", and reserves and shall have the right to order one or more of the "new units" at the price submitted with each selected bid or selected portion of the selected bid. Calhoun County may order additional "new units" at the price quoted by each selected bidder, as needed, for and up to 12 months of the award of a contract to each selected bidder.

Notwithstanding anything else herein provided, if a bid is awarded, it shall be awarded to the lowest responsive, responsible bidder.

All applicable federal and state laws, municipal ordinances, and rules and regulations of all authorities having jurisdiction to this project shall apply to the contract, awarded to each selected bidder, throughout and will be deemed to be included in the contract with each selected bidder the same as though herein written in full.

The bidder expressly acknowledges, to and for the benefit of the Calhoun County Commission, that bidder expressly warrants and agrees that he/she/it shall at all times comply with all applicable federal, state, local and municipal laws and regulations.

Bids may be mailed early enough that they are received prior to the bid opening date and time or bids may be hand delivered early enough that they are received prior to the bid opening date and time to the Calhoun County Commission, 1702 Noble Street, Suite 103, Anniston, Alabama, 36201. The Commission cannot guarantee that bids sent by mail or courier will be received on or before the bid opening day and time as required. Bids received after the deadline <u>will not</u> be accepted and will be returned.

The awarding authority of a contract to each selected bidder is not a notice to proceed. A purchase order must be obtained before any items/work can be purchased/performed. A purchase order will be issued to each selected bidder for the work listed in the bid documents.

Each selected bidder will be required to submit a properly completed and executed Internal Revenue Service Form W-9 and a Calhoun County Business License to provide equipment, supplies, materials, and services as herein provided. In addition, each selected bidder must complete all necessary paperwork required by the County for verification of enrollment in the everify program to verify full compliance with the Immigration Reform and Control Act of 1986, as amended by Immigration Act of 1990 and the Beason-Hammon Alabama Taxpayer and Citizen Protection Act, as amended or changed or modified by or due to Court order.

Each selected bidder will, by accepting the award of a contract, agree to the following: By signing this contract, the contracting parties affirm, for the duration of the agreement, that they will not violate federal immigration law or knowingly employ, hire for employment, or continue to employ an unauthorized alien within the state of Alabama. Furthermore, a contracting party found to be in violation of this provision shall be deemed in breach of the agreement and shall be responsible for all damages resulting therefrom.

In compliance with Ala. Act No. 2023-409, by signing this contract, Contractor provides written verification that Contractor, without violating controlling law or regulation, does not and will not, during the term of the contract engage in economic boycotts as the term "economic boycott" is defined in Section 1 of the Act. This requirement applies to contracts entered into on or after October 1, 2023 if Contractor employs 10 or more employees and the contract could exceed \$15,000 over the term of the contract. Under Section 2 of the Act, the written verification may be waived if the contracting governmental entity determines based on cost and quality factors that such a waiver is clearly in the best interest of the public.
