SUMMARY OF MINUTES CALHOUN COUNTY COMMISSION April 11, 2024

Chairman Shears called to order the regular meeting of the Calhoun County Commission at 10:00 a.m., with Commissioners Fred Wilson, Terry Howell, and Lee Patterson present. Commissioner Terry Howell gave an invocation and led the Pledge of Allegiance.

Ms. Audrey Maxwell, Chamber of Commerce Tourism Director, announced several events in our area this weekend: Historical walking tours in Oxford, Camp Lee 5k trail run, Noble Street Festival all day Saturday, and the Sunny King Criterium with cyclists from all over the nation participating. She also announced that the Chief Ladiga Landing extension groundbreaking will be next week, and the opening of Hess Grocery at the McClellan Horse Trails will be on Saturday.

Mr. Jakob Williamson, Chamber of Commerce Public Affairs Coordinator, announced the State of Higher Education coming up on April 24 with Dr. Killingsworth and Dr. Murphy at the GSCC Ayers Campus.

Commissioner Howell announced that CASA's second annual No Excuse for Child Abuse Candle vigil will be next Wednesday, April 24, at 7 p.m. at Oxford's Veterans Park and encouraged everyone to attend.

Commissioner Howell made a motion to adjourn, which was seconded by Commissioner Wilson. All Commissioners present voted in favor of the motion by voice vote. Accordingly, the meeting adjourned at 10:18 a.m.
