Janney Furnace Park Rules and Regulations

1. The Park will only be rented to persons age 21 or older. (If the Park is used for children or teen activities, adult chaperones must be present at all times.)
2. Groups of 75 or more must have a security guard present at all times.
3. Alcoholic beverages are not allowed on the property.
4. Heating and cooling unit may be adjusted to need, but must be returned to the original setting before leaving.
5. Furniture and other contents inside the buildings may be rearranged for the event, but may **NOT** be taken outside the building.
6. Chairs and tables must be returned to original order.
7. Facility must be cleaned and orderly.
8. All garbage must be placed in trash containers. {Trash bags are not furnished.}
9. Make sure the commodes are flushed and bathrooms are clean.
10. Keep Welcome Center doors closed to insure proper heating and cooling.
11. When the kitchen is used, all appliances and kitchen equipment must be clean and orderly.
12. Make sure the lights are off and doors are locked before leaving.
13. Be sure that everyone has left the Park at the designated time.
